The amount of duty depends on the size and weight of the shipment and where it come from. The KITAS and Work Permit can take between 2-6 weeks to obtain once client have arrived in Indonesia. Furthermore to obtain Duty-Free import of household goods items –</p> <ul style="list-style-type: none"> Can only import a 'reasonable' quantity of major appliances (refrigerators, stoves, freezers etc.) and electronic items (i.e. stereo, televisions etc.). 1 of each item Only one sea and one air shipment is allowed per family unit and must be imported within 3 months from client arrival date in Indonesia (per Immigration Admission Stamp in client's passport). If it arrives after this time, then duties and taxes will apply.
