Importation of wooden packages		<p>Peru has adopted the International Regulations on Phytosanitary Policy (NIMF) N° 15 on wooden packing used in international trade, enforced by the FAO in 2002. This regulation describes the phytosanitary measures applicable in order to reduce the introduction and plague dissemination risk through wooden packing materials.</p> <p>Phytosanitary inspection will be done at the port/airport of entry in Peru. If packing materials are not marked per NIMF N° 15, entry will be denied. If packing materials are properly labelled, but evidence of live plague is found, Customs may deny entry, put packages in quarantine, order their treatment, return them to origin or destroy them.</p>	<p>Compliance with this regulation is mandatory in Peru as of September 01, 2005.</p>
